Bios of Nominees for 2018 Board

Colin Neilson: Board member since 2014 and currently vice-chair.

Colin is a retired RCMP member and he served as their representative on the CRD Enhanced 9-1-1 project. The unnecessary complexity originally built into the region's 9-1-1 system to accommodate multiple emergency response agencies convinced him that a regional emergency centre would provide more effective and efficient service. Colin has lived in Greater Victoria since 1967.

Bill Carver: New nomination to the Board.

Former police office with three different police departments--Edmonton, Central Saanich and Victoria where he was involved as emergency response coordinator for the Commonwealth games.
